In signing below, I acknowledge that my student will not be permitted to use the eReader at other times during school hours, including while on classroom extensions and during other school-sponsored events.

I understand and agree that Pennsbury School District is not responsible for any damage or loss associated with my child's eReader, nor is it responsible for any costs incurred relating to the downloading of content to the device or access to any content providers through the device. I also understand that bringing an eReader to school is a privilege and may be terminated at any time. I further understand that this privilege is designed for educational purposes only and that a violation of this agreement may result in my child losing the privilege to bring his/her eReader to school for a length of time commensurate with the nature of the violation and other school discipline.

I also recognize that it is impossible for Pennsbury School District staff to monitor all activity on personal devices, and the student, parent, and/or guardian will not hold Pennsbury School District, the School Directors, nor any individuals employed by Pennsbury responsible for damages related to my child's use of the eReader, or for content viewed by any student on the eReader, including via a personal internet connection.

Important: for clarification purposes, please read the following carefully. Your signature on this form acknowledges your understanding of this agreement in its entirety.

A device that serves the purposes of communication, playing music or games, and also allows electronic books, would not be classified as an eReader under this agreement.
- The use of eReaders during testing is strictly prohibited.
- All material on the eReader and accessed on school property or during school-sponsored events must comply with the educational objectives of the Pennsbury School District.
- Pennsbury School District assumes no responsibility for any data contained on any personal electronic device.
- Pennsbury School District assumes no responsibility in any circumstances for loss, destruction, damage, theft, or charges made on monthly statements for an electronic reading device. Students will be responsible for locating any lost/stolen items and for other expenses accrued to their personal eReader accounts.
